State Licensure Requirements:

Miller-Motte College's Pharmacy Technician program prepares graduates to sit for the national certification exam to obtain a Certified Pharmacy Technician (CPhT) certification credential. The Pharmacy Technician program is a Pharmacy Technician Certification Board (PTCB) Recognized Education/Training Program. Eligibility requirements for the CPhT include a passing score on the Pharmacy Technician Certification Exam (PTCE) with PTCB or the ExCPT Certification Exam with the National Healthcare Association (NHA).

The following states currently have no licensure requirement to obtain employment as a pharmacy technician, although some may require registration:
